










On-Campus Positive Tests


COVID RETURN TO CAMPUS

Evolution of the Pandemic-Personal Responsibility

- No return to campus testing
- Voluntary saliva based PCR testing through COP- no charge
 - Those preferring testing at SHS- will result in charges
- Masks encouraged throughout campus
 - KN95s available at the Welcome Center
- Vaccines encouraged- available daily at CHW
 - No charge with insurance card
- Positive test result
 - Isolation dates calculated based upon testing date
 - 5 day isolation plus 5 days tight fitting mask
 - Patients instructed to alert their own close contacts
 - Letter sent to patients with dates for isolation, same letter for class excuse with Ombuds
- No University isolation housing
- Special circumstances, contact Ombuds office
- No Covid dashboard

 - Do not call HD directly
 - Call M-F 8am-6 PM



Expanded PEP / PEP++

MSM with multiple or anonymous sex partners in the last 14 dayspriority population for vaccination

- 3 Eligibility Criteria
- Identify as gay, bisexual, transgender, gender non-conforming or gender non-binary and has sex with men
- 2. Aged 18 or over
- 3. Had multiple or anonymous sexual partners in the last 14 days

Vaccine clinics happening now!




